Appropriate engineering controls

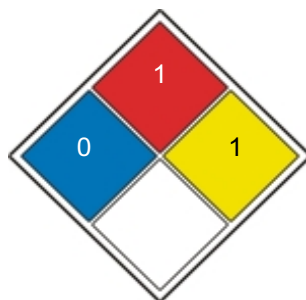
