Appropriate engineering controls

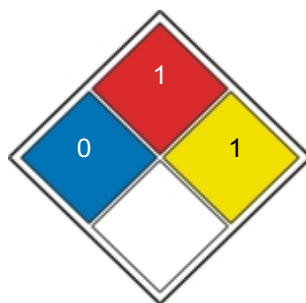
