Appropriate engineering controls

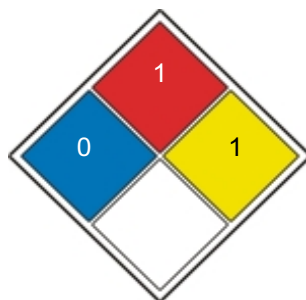
